"I have often thought it may have been better to have died during this attack... The offender will never suffer the anguish, fear and terror I have faced during and since his violent attack." -Rape

"Though it was in 1987, I can no longer sleep in that house...I will never feel safe in that house again." -Burglary and breaking and entering

"I was very fearful for a long time, unable to return to the house I had lived in for more than 50 years for quite a while after the crime."

-Breaking and entering

- Input by appointment, written statement, or verbal statement
- More than 700 victims have provided input in the last year

"I hope you never know the hurt and pain that comes with having to relive that horrible night every time this parole time comes up."

"This is an impossible letter to write, as it seems so unjustly unfair to endure the hardship this process causes each time it comes around."

-Child sexual assault

"Although he is in prison for what he did, I have also been punished, as he has successfully imprisoned me in a psychological prison from which I will never be paroled, will never escape, and will never find release so long as I am still alive." -Rape

"How I wish my case was under Truth in Sentencing guidelines, which would relieve me of my duty to attend to parole matters...As a victim of a violent sexual assault, I'm forced to relive the assault at parole time, and brood over the possibility of his release from prison until I get a call with the Board's decision."

"My mother never got over the fear he created. It wrecked her life from 1995 until her death in 2014."

-Breaking and entering

GERIATRIC CONDITIONAL RELEASE

"The sentencing must be carried out or all the court rituals, lawyers, time, and meetings have been a waste of time."

"Please don't do this to us. We have hurt enough." "The offender made the conscious decision that my loved ones didn't deserve to see age 60-65. Has the passing of time diminished the seriousness of his crime? Are my son's and nephew's any lives less significant now than when the offender was sentenced to serve 2 life terms?"

"How dare you! This is an insult to the victim's family."

While we cannot take back what has happened, we CAN:

- Ensure we do not further victimize or re-traumatize those who are already suffering
- Deeply and carefully consider the impact any new laws and policies will have on victims of crime
- Not disregard the lifelong suffering that these crimes have caused, and the continual involvement of the criminal justice system in the lives of those trying to heal and move forward
