CALL TO ORDER

Vice Chairman Banks called the meeting to order at 1:00 p.m.

ESTABLISHMENT OF MAJORITY

Vice Chairman Banks determined that all members of the Board were present.

APPROVAL OF THE AGENDA

Upon motion by Mr. Ferguson, with a second by Mr. Boone the agenda was approved as written.

APPROVAL OF THE MINUTES

Upon motion by Ms. Dermeyer, with a second by Mr. Ferguson, the minutes of the April 23, 2025 meeting were unanimously approved as written.

PAROLE CONSIDERATIONS

Vice Chairman Banks provided an explanation of the change to § 53.1-136 of the *Code of Virginia* effective July 1, 2024, which requires a public meeting be convened to conduct the final deliberation and vote regarding whether the Board will grant parole to a prisoner.

Gregory Widener, #1083217

Mr. Widener was considered for both Discretionary Parole and Geriatric Conditional Release.

Vice Chairman Banks provided an overview of Mr. Widener's circumstances and period of incarceration.

Vice Chairman Banks provided the Board members an opportunity to ask questions of Mr. Tynes.

Vice Chairman Banks then called upon each member to give their vote and reason(s) for their vote.

**Board Member Boone – Grant**, based on demonstrated rehabilitation and release being compatible with public safety.

**Board Member Ferguson – Grant**, based on demonstrated rehabilitation, infraction free for 24+ months, no history of violence, release is compatible with public, low risk assessment score, and Board member believes he has served enough of his sentence.

**Ms. Dermeyer – Not Grant**, due to extensive criminal history and Board member believes he should serve more of his sentence.

**Vice Chairman Banks – Grant**, based on demonstrated rehabilitation, release being compatible with public safety, and no history of violence.

**Final votes were 3 in favor of granting parole/geriatric conditional release and 1 opposed.**

Vice Chairman Banks congratulated Mr. Widener, as the majority of members present voted to grant parole/geriatric conditional release. He then reminded him that he must continue to remain of good behavior throughout the re-entry process, as any infraction could put his release in jeopardy. Vice Chairman Banks also explained that Mr. Widener will be given conditions of his parole upon his release.
